# **VALIDATION OF SOURCES**

Our Advisory is evidence-based. Information for this narrative has been from Jewish and Israeli sources as well as the United Nations and official NZ government sources. At times we have referred to US and UK news agencies, such as the New York Times, Time, Guardian and Wall Street Journal. We have not used Arab, Muslim or Asian news sources, including Al Jazeera. This is to avoid potential allegations of bias. All data and historical accounts have been fact checked with sources and dates provided for validation.



# BRIEF

Our previous advisory in November 2023, referred to the Unfolding Humanitarian Crisis<sup>1</sup>. The situation in Palestine is now much worse.

The UN Secretary General, António Guterres has aptly stated that it is now a 'crisis of humanity'2.

As the world witnesses and as UN warns of the genocide<sup>3</sup> unfolding in Gaza, our **call for action** is based on the reality and conviction that whilst Aotearoa New Zealand may not be a global power-base, we can however remain humanity's bell-weather nation for international peace and humanitarian justice. It is time for our government, civil society and the media to do right by those suffering injustice and systematic genocide.

This advisory covers a number of intersecting issues -

• Requesting our respective government agencies to provide necessary clarification on key issues, so that civil society and our elected representatives can make informed decisions on our foreign policy, national security and domestic social cohesion.

• Advocating our strongest support against anti-Semitism and in the process clear the cobweb of misinformation, misdirection and hate baiting.

• Highlighting the importance of the Fourth Estate to provide balanced and informed perspectives.

As with any international crisis of this proportion, we recognise that there are different perspectives on the end-solution. Consistent with our previous advisory, we believe no lasting peace will be achieved through violence and that a two-state solution is the most viable option for the future. Furthermore, for the International Rule of Law to prevail, Aotearoa New Zealand needs to persevere with patience, wisdom and a firm resolve to hold those who are responsible to account.

# **1.00: THE NINE CONSIDERATIONS**

Every 10 minutes a child is being killed and two others maimed in Gaza<sup>4</sup> due to the calculated bombing of innocent civilians by the Israeli army (IDF).<sup>5</sup> Over 22,000 innocent civilians have been killed in Gaza so far.<sup>6</sup> Unfortunately, the daily vivid images of death have numbed our senses to only focus on the statistics. History has shown that sometimes such numbness can quite readily transition into collective apathy. As such, this advisory is a call for action.

To guide our path to informed decision-making, both for civil society and our politicians we have sought specific clarification from our relevant government agencies. This clarification is essential and is in keeping with Aotearoa NZ's new National Security Strategy<sup>7</sup> which stresses that collective understanding and approaches to decision-making requires being informed.

#### FIANZ have requested clarification on the following nine considerations.

• 1.01 Collective Punishment

By affirming Article 33(1) of the Fourth Geneva Convention, NZ has a responsibility to seek an end to the collective punishment of Palestinians in Gaza

• 1.02 IDF as a Terrorist Organisation

Designation of the IDF as a terrorist organisation in keeping with Article 5 (definition of Terrorist act) of the Terrorism Suppression Act 2002

• 1.03 Visa Ban on Extremist Israeli Settlers

Condemn and impose visa bans on Israeli extremist settlers.

• 1.04 Consistent Application of Immigration Act

In the past our community has been subjected to provisions of the Immigration Act which we believe should be reconsidered now.

- 1.05 Support the South African position at the International Court of Justice We have already noted that South Africa has taken a lead on this. It is our view that NZ should support the South African case at the ICJ.
- 1.06 NZers going Abroad for Terrorism

NZSIS to give similar media statements as they gave earlier about NZ'ers going abroad to take part in terrorism.

• 1.07 Cancel Securities Commission MOU with Israel

Cancel the Memorandum of Understanding between the NZ Securities Commission and Israel Securities Authority.

• 1.08 End Purchase of Security Equipment

End all security and military relations with the government of Israel and Israeli companies, including the purchase of security related equipments by the NZ Army and the NZ Police.

• 1.09 End WHS for IDF Terrorists

Stop the Working Holiday Scheme which offers 200 places in NZ for Israelis who are part of or have been part of the Israeli Army (IDF). A similar scheme should also be made available for Palestinians.



## 1.01 Condemn Collective Punishment

We kindly request our MFAT officials to consider the following:

The International Military Tribunal at Nuremberg at the end of the Second World War, noted "[t]he Germans pursued a systematic policy of inflicting, in all the occupied territories, collective penalties, pecuniary or otherwise, upon the population for acts of individuals for which it could not be regarded as collectively responsible."<sup>8</sup> This is Collective Punishment and an international crime against humanity as noted in the Fourth Geneva Convention (Art 33(1)).<sup>9</sup>

New Zealand assented to the Convention and the Act is administered by the Ministry of Foreign Affairs and Trade (MFAT).



We are requesting our MFAT officials, who administer the above legislation, to determine whether what is happening in Gaza can be regarded as collective punishment or not? The overwhelming global response is obvious;

We also kindly request MFAT to clarify the following on 'self-defence'. :

i) Has the statement on 'self-defence' by our government provided Israel with a carte blanche justification for the indiscriminate mass-slaughter of civilians through carpet bombing ?

ii) Is MFAT aware that the 2004 International Court of Justice (ICJ) ruling which decreed that Israel, as 'an occupying power', have no right under international law to use the rationale of 'self-defence'? [The above ruling was the illegal building of a separation wall in occupied Jerusalem ] As such, what advice did MFAT provide to the government on the 'self-defence' rationale and its applicability in the current context ?

iii) Does MFAT agree that Under Article 42 of the Fourth Hague Convention, an occupation is defined as: "Territory is considered occupied when it is placed under the authority of the hostile army. The occupation extends only to the territory where such authority has been established and can be exercised" ?

iv) Does MFAT agree with the following prominent organisations and international bodies such as

• the International Committee of the Red Cross (ICRC),

• the UN Independent International Commission of Inquiry on the Occupied Palestinian Territory,

- the UN General Assembly (UNGA),
- the European Union (EU),
- the African Union (AU),
- the International Criminal Court (ICC),
- Amnesty International (AI), and
- The Human Rights Watch (HRW)-

that Israel has occupied Palestinian territories, including Gaza, since 1967.<sup>13</sup>

v) Given the above does MFAT agree that Israel has ignored international law? We contend that NZ has consistently advocated for the international rule of law. The occupation laws under the Fourth Geneva Convention 1949, the 1907 Hague Regulations makes it illegal for annexation of land, destruction and seizure of property and the forcible transfer of people, all of which Israel has been doing in Gaza and the West Bank.

Simply put, our government cannot override our affirmed and mandated international responsibilities with respect to Article 33(1) of the Fourth Geneva Convention on 'collective punishment'. Israel has ignored and broken international law and this should be the baseline of NZ's response to the current tragedy in Gaza and included in our official government statements.

Moreover, we are seeking clarification based on the existing ICJ ruling, that Israel cannot use self-defence as justification for the on-going genocide and mass killing of innocent civilians.

### **1.02** Designation of IDF as a Terrorist Organisation

As the two advising agencies on the Terrorism Suppression Act, as noted in the Regulatory Impact Statement<sup>14</sup> we kindly request clarification from the Department of Prime Minister and Cabinet (DPMC) and the Ministry of Justice (MOJ) as to whether the IDF<sup>15</sup> should be classified as a terrorist organisation in keeping with the Terrorism Suppression Act 2002



(2) An act falls within this subsection if it is intended to cause, in any 1 or more countries, 1 or more of the outcomes specified in subsection (3), and is carried out for 1 or more purposes that are or include advancing an ideological, political, or religious cause, and with the following intention:

#### (a) to intimidate a population; or

(3) The outcomes referred to in subsection (2) are-

(a) the death of, or other serious bodily injury to, 1 or more persons (other than a person carrying out the act):

(b) a serious risk to the health or safety of a population:

(c) destruction of, or serious damage to, property of great value or importance, or major economic loss, or major environmental damage, ...

(d) serious interference with, or serious disruption to, critical infrastructure, if likely to endanger human life:

The available evidence is that every one of the criteria may be substantiated, particularly the killing of over 22,000 innocent Gazans, almost 70% of whom are women and children.

As such we seek clarification from the DPMC and the MOJ as to the following: i) Do the above mass killing, which the UN has also stated is 'ethnic cleansing' qualify as terrorism under our Terrorism Suppression Act ? We would be pleased to receive a rationale for your response.

We are aware of the exception that 'an act does not fall within subsection (2) if it occurs in a situation of armed conflict and is... in accordance with the rules of international law applicable to the conflict'<sup>16</sup>

ii) In the context of the above exception, does the DPMC and MOJ agree that Israel is in violation of many international laws with respect to its occupation and the longstanding mass killing of innocent civilians through carpet bombing in Gaza?

The NZ government has designated the Hamas Military wing as a terrorist organisation and is now considering the same designation for the Hamas political wing.

We would request the same criteria that has been used for the Hamas designation as a terrorist organisation, be also used for the IDF .

Our request for clarification is in keeping with the new NZ national security strategy which highlights that civil society needs to be made aware and informed.

We seek information from our respected agencies who had earlier advised on the hurried introduction of the Terrorism Suppression Act, to also inform civil society and the government on the applicability of the NZ law with respect to designating the IDF as a terrorist entity.

This is a matter of urgency.

### 1.03 Ban on Visa for Israeli Terrorist/Extremist Settlers

As a Five Eyes partner, NZ consistently follows the lead of the USA on matters of international foreign policy and national security. We now note that our new coalition government is also advocating a case for NZ to join Tier 2 of AUKUS. In this respect we kindly seek an explanation from MFAT and MBIE on the following:

- Have the coalition government been advised that the US and the UK have already stated they will ban visas for extremist Israeli settlers? If so when was the government advised.
- ii) If the government has not yet been advised , then when will they do so .
- iii) Moreover, will this advice also extend to deporting Israeli settlers who are currently in NZ?

### Acknowledgement

We acknowledge our Prime Minister, Rt Hon Chris Luxon's position that Israeli settler violence is a key obstacle to peace .



"We reaffirm that settlements are illegal under international law. Settlements and settler violence are serious obstacles to a negotiated two-state solution."

Prime Minister, Rt Hon Christopher Luxon, 13 December 2023

We contend that the above position should now be translated into a visa ban for extremist Israeli settlers, similar to that which our Five Eyes partners, the US and UK governments have already announced.

We trust a formal statement on a visa ban for extremist Israeli settlers shall be forthcoming shortly.

### 1.04 Consistent Application of the Immigration Act

We are seeking an explanation from MBIE as to why the same immigration provision that targeted our community in the past have not been introduced now ? Are there currently similar legislation with such targeted specificity?

For the record, laws were introduced which aimed at potential terrorists (including later as jihadi brides<sup>20</sup>) who would join terrorist organisations in Syria, Afghanistan, Somalia and elsewhere. A copy of the applicable legislation which was introduced is below:

D7.65 Deportation of people threatening national security and suspected terrorists Immigration Act 1987 ss 72, 73 1. If the Minister of Immigration certifies that the continued presence in New Zealand of a person named in the certificate constitutes a threat to national security, the Governor General may order the person's deportation. 2. The Minister of Immigration may order the deportation of any person if the Minister has reason to believe that: 1. the person is a member of or adheres to any organisation or group that has engaged in, or has claimed responsibility for, an act of terrorism in New Zealand or outside of New Zealand, and constitutes a threat to public safety; or 2. the person has engaged in, or claimed responsibility for, an act of terrorism in New Zealand or outside of New Zealand, and constitutes a threat to public safety; or 3. the person will, if permitted to remain in New Zealand, engage in, or facilitate the commission of, an act of terrorism. 3. The Minister of Immigration may revoke a deportation order made under section 73 of the Immigration Act 1987 at any time. 4. People subject to deportation under section 72 of the Immigration Act 1987 have no right of appeal. 5. Sections 74 to 88 of the Immigration Act 1987 set out matters in relation to deportations under sections 72 and 73 of the Act. Effective 01/10/1999

We note that the above has since been rescinded. However, the principle remains that NZ must be consistent in its application of such laws.

As such we kindly request :

- i) An explanation from MBIE, if currently there is similar explicit law exists to deport?
- ii) In the above context, we seek clarification and assurance from the MBIE, NZSIS and MFAT, that there are no persons going from New Zealand or have gone from NZ, to take part in the genocide and mass killing of women and children in Gaza?

We note that the current coalition government have a policy that there should be the same applicable laws for everybody. If a law was introduced earlier to deport such potential terrorists, we contend that such a law should be re-introduced now, unless there is already a similar legislation in place.

Failure to do so is simply advocating dual standards.

# 1.05 Genocide and the Breakdown of Rule of International Law

On 1 November 2023, the Prime Minister- elect, the Rt Hon. Chris Luxon stated that he had not "seen any advice" to suggest that Israel is not respecting international law in Gaza.<sup>21</sup>

In this respect, we seek clarification on the following matters from MFAT and DPMC:

- Have our Foreign Minister, the Rt Hon Winston Peters and the Prime Minister, the Rt Hon. Chris Luxon been given advice since then (after 1 November) on the unfolding tragedy in Gaza?
- We particularly seek clarification on whether any advice have been given tas to whether Israel has complied with all applicable international laws and conventions, including the Convention on the Prevention and Punishment of the Crime of Genocide<sup>22</sup>?
- iii) In this respect, have the Prime Minister and the Foreign Minister been briefed on the following:

#### • U.N. Special Advisers on the Prevention of Genocide

"The International Criminal Court (ICC) has jurisdiction over genocide, and the U.N. Special Advisers on the Prevention of Genocide issued a statement two weeks into the 2014 offensive that they were "disturbed by the flagrant use of hate speech in the social media, particularly against the Palestinian population," finding that "individuals have disseminated messages that could be dehumanising to the Palestinians and have called for the killing of members of this group," while "remind[ing] all that incitement to commit atrocity crimes is prohibited under international law."<sup>23</sup>

#### International Criminal Court

The International Criminal Court has an ongoing investigation since 2021 into possible war crimes and crimes against humanity in the occupied Palestinian territories.

#### • UN High Commission for Human Rights

The UN High Commissioner for Human Rights, resigned over what he called this a "text-book case of genocide"

#### Amnesty International

Amnesty International submitted a Report to all governments in 2021, including NZ, on how Israeli forces have committed in Gaza (as well as in West Bank and Israel) acts prohibited by the Rome Statute and Apartheid Convention,

- iv) Have the Prime Minister and the Foreign Minister been advised that the International Criminal Court prosecutor, Karim Khan has stated that Israel must respect international law?

" Schools, hospitals, churches and mosques, dwelling houses are protected and must not be bombed. I've made it clear what the law is in terms of the principles of distinction, precaution, and proportionality. And leaving aside all of those issues, I've made it also abundantly clear that the law can't be interpreted in a way that it denudes it from meaning, that hollows it out, that fails to achieve what the Geneva Conventions were meant to do, which is to protect the most vulnerable of society, babies and children, the old and the infirm, civilian men and women.<sup>724</sup>

We are requesting MFAT & DPMC officials to provide civil society with a copy of the advice given to our Prime Minister and the Minister of Foreign Affairs on the international rules-based order as well as the serious issue of genocide, with respect to Israel.

We have noted that South Africa has recently instituted proceedings in the International Court of Justice (ICJ) against the State of Israel on 29 December, which seeks provisional measures to ""protect against further, severe and irreparable harm to the rights of the Palestinian people under the Genocide Convention" and "to ensure Israel's compliance with its obligations under the Genocide Convention not to engage in genocide, and to prevent and to punish genocide."<sup>25</sup>

In this respect, has MFAT provided any advice to the government on the South Africa's proceeding at the ICJ ?

Furthermore, given that NZ has already set a precedent at the ICJ on 20 September, 2023 by intervening to support the case against Russia, we consider a similar rationale for an intervention may also be applicable in support of the South African case.

At the ICJ on 20 September, our NZ Chief International Legal Adviser stated :

"New Zealand has chosen to intervene in these proceedings because we consider that the issues in this case go to the very heart of the international rule of law and the protection of this Court's role in the peaceful settlement of dispute."

It is our contention that Israel has broken international rule of law and there exists sufficient evidence of Israeli genocide against Palestinians.

NZ should intervene pursuant to Article 63 of the Statute of the International Court of Justice in the case of the Application by South Africa against Israel concerning violations by Israel of its obligation under the Convention on the Prevention and Punishment of the Crime of Genocide (the "Genocide Convention") in relation to Palestinians in the Gaza Strip.<sup>27</sup>

It is our view that NZ should file a Declaration of Intervention in the above proceedings under Article 63 of the Statute . NZ should avail this right to intervene given that we have a common interest in the accomplishment of the high purposes of the Convention and our humanitarian concerns over the continued mass-killing of innocent Palestinians, particularly women and children, in Gaza and the need for international co-operation in the quest to prevent and punish genocide. Till the decision is made by the ICJ, we respectfully request that our government needs to ensure our humanitarian and independent stance on this conflict.

In addition to the above, we have always maintained that there should be independent international investigation and justice for the innocent civilians killed. This should include what happened on 7th October and the subsequent period when over 22000 civilians have been killed.



### 1.06 Monitoring IDF Soldiers in NZ & Warnings About NZers going Abroad for Terrorism

We request clarification from the NZSIS on the matter of Israeli citizens with dual nationalities who are traveling to Israeli to serve in the IDF. By many accounts, including the UN, the IDF is engaged in the ethnic cleaning and genocide of Palestinians in Gaza.<sup>28</sup> Is the NZSIS monitoring this situation?

It is also important to note that according to Israeli law, even dual New Zealand Israeli citizens must serve in the Israeli army. <sup>29,30</sup>.

Arrangement of Military Status (Israeli Citizens)

Service in the IDF is obligatory for Israeli citizens. This law applies to:

- Citizens, whether they reside in Israel or abroad, even if they have another nationality.

Permanent residents of Israel, even if they are not Israeli citizens.

As such, Israeli dual citizens may have in the past and may now be participating in the ethnic cleansing and genocide of Palestinians.

Terrorism is a key focus of the NZSIS and in this respect what has the NZSIS done to monitor such Israelis who are or have been in NZ, and who may have been directly involved in ethnic cleansing and genocide?

Furthermore, when are we likely to get statements like those warnings issued by the NZSIS in the past about jihadi brides and NZ'ers going to Syria? We have yet to see any statements from the NZSIS warning Israelis (with dual nationalities) going abroad to join the war of ethnic cleansing and genocide of Palestinians.

One of Israel's major national newspaper has clearly stated:31

The Israeli Army Has Dropped the Restraint in Gaza, and the Data Shows Unprecedented Killing

The IDF chief of staff recently boasted of the army's precise munitions and its ability to reduce harm to noncombatants. But the data shows that in the war on Hamas that principle has been abandoned



There is ample evidence that the IDF are directly complicit in the killing of innocent civilians, particularly children, in Gaza as part of their collective punishment and systemic genocide of Palestinians.

NZISIS have always been very forthright on the matter of countering terrorism both here and abroad. We would be grateful for a clarification on this matter from the NZSIS and also clarification as to which legal precepts are being followed in terms of NZ'ers going overseas to join wars/terrorism and genocide. We are particularly interested if there is a dual policy in this respect with one for Palestinians/Arabs and another for Israelis ?

### **1.07** Cancel the MOU with the Israeli Securities Authority

We note that NZ has an exchange of Information and Surveillance Securities with Israel since 2005.<sup>32</sup> This should be cancelled as part of our response to the Israeli government's genocide of innocent Palestinian civilians.



We would like to thank the Foreign Minister, the Rt Hon Winston Peters for confirming our earlier request for clarification that the Agreement between the Government of Israel and the NZ Government on Cooperation in Technological Innovation, Research and Development is not in force anymore.

We trust that the MOU shall be cancelled

# 1.08 STOP THE PURCHASE OF ALL ISRAELI SECURITY EQUIPMENT AND MILITARY TIES

NZ tax-payer funds should not be used to support Israeli military supplier companies.

 Purchased from Israeli company Rafael, the Armor Shield P system in 2019, which is an add on armour for combat vehicles. Rafael was founded as Israel's national R&D Defense Laboratory and supplies the IDF.

 Israeli company Roboteam, another Israeli company, is a provider of tactical ground robotic systems. NZDF awarded them a contract for remote controlled robotic systems. The contract value has been kept confidential.

• EL/M- 2022 aircraft radars have also been bought from Israel.

• With respect to cyber security, the NZ Police uses Israeli Cellebrite's UFED Cloud Analyzer tool.

• Briefcam's Video analytics are also bought from Israel.

We request the NZ Defense Force and the NZ Police to reconsider the purchase of equipments from Israel. This is directly assisting the IDF to continue the genocide and ethnic cleansing of Palestinians.

#### Past and forthcoming US-Led War Games With Israeli Military Presence

In 2022, New Zealand joined Israel, along with about 24 other countries, in the USA organised Rim of The Pacific (RIMPAC-2022) maritime exercise led by the US Third Fleet (Hawaii and Southern California)

We understand that this exercise will again be held this year (2024). We request that NZ does not join Israel in this exercise. This would be tantamount to giving tacit approval to the current genocide being committed by Israeli forces.

We would also like to know if NZ participated in the Juniper Falcom23 (CENTCOM/Israel)<sup>33</sup> war games or any of the 109 other US-led war games held in 2023.

We request the NZ Defense Force to reconsider any overseas training which has a direct or indirect nexus with the Israeli military.

### 1.09 Stop the Working Holiday Scheme for IDF Terrorists

Stop the Working Holiday Scheme (WHS) which offers 200 places in NZ for Israelis. It should be noted that Israel has compulsory military conscription for every student finishing high school. They are trained by the IDF and must serve two or three years. By allowing Israelis between the ages of 18 and 30 to come here, NZ is effectively allowing trained IDF soldiers to come to NZ.

There is ample evidence that the IDF is directly involved in the genocide of Palestinians and NZ must not allow them to come to NZ to work here.

Furthermore, it is absolute double standards that NZ does not allow Palestinians such working holidays.

We request NZ Immigration to cancel the WHS scheme for Israelis in NZ, since every Israeli above the age of 18 is required to train and serve in the IDF . As such , these ' working visitors' are also trained and have participated in ethnic cleansing and the genocide of Palestinians.

# 2.00: ANTI-SEMITISM HAS NO PLACE IN Aotearoa new zealand

Anti-Semitism, Islamophobia and any type of discrimination and hatred has no place in Aotearoa New Zealand.

After 7th October, at the initiative of the Wellington Abrahamic council, both FIANZ and the NZ Jewish Council, as well as many other Jewish and Christian organisations, have issued a joint statement on 20 October, 2023. We thank Dave Moskovitz, Jewish Co-Chair, Wellington Abrahamic Council for his pivotal role in this initiative.

#### **REJECTING ALL FORMS OF HATE AND BIGOTRY**

This is a moment of deep pain in the world. Since the events of 7 October in Israel and Gaza, we have seen exploitation of the crisis to spread hate, disinformation and extremism overseas and here in Aotearoa New Zealand.

Let us be unequivocally clear:

We the undersigned reject all forms of hate and bigotry, including racism, Islamophobia, anti-Arab hate, and antisemitism. We are reminded that all of our communities' safety and futures are inextricably linked – and we recommit ourselves to fighting racism, bigotry, and hate in all its forms.

The Torah commands us to "love your neighbour as yourself".

The New Testament enjoins us to "love one another".

The Quran teaches us that The Almighty has created different "peoples and tribes that we may know one another".

We stand together with all of our neighbours under threat and urge our elected and community leaders, police, schools, universities, public institutions, employers and workplaces to make clear that there will be zero tolerance for any act of hate.

L'shalom, Salaam, Kia tau te Rangimārie - towards peace and justice in our world.

The Wellington Abrahamic Council of Jews, Christians, and Muslims

After 7th October, FIANZ has had consultations with the NZ Jewish Council and others. At issue is to stress our full commitment against terrorism or the killing of innocent civilians. We also acknowledge the traumatic impact on the diaspora communities in Aotearoa NZ including the closure of Jewish schools and synagogues due to threats. Such cases of hate-inspired threats have no place in Aotearoa NZ.

# We are categorically opposed to anti-semitism and any unlawful actions which jeopardise our peaceful way of life here in NZ.

We as a community know more than most just how fragile this peace can be and how hard we need to work to preserve it and ensure that it flourishes. In this respect, within 12 hours of the swastika graffiti incident of a prominent statue a former Auckland Mayor, the Federation immediately released a media statement condemning the action.

The statement read:

#### FIANZ MEDIA STATEMENT

#### VANDALISM OF RELIGIOUS AND COMMUNITY PLACES

At a time of the unfolding human tragedy of genocidal scale in Gaza, we urge that all concerns should be expressed through legitimate and peaceful means, which include protests and advocacy, said Ibrar Sheikh, President of the Federation of Islamic Associations of New Zealand (FIANZ). There is no place in Aotearoa for desecrating community and religious places, as was recently reported of the Jewish community centre and synagogue, Epsom, Auckland. FIANZ condemns this act of vandalism. All places of religious gathering such as Synagogue, Churches, Mosques, Temples and Gurudwaras where communities gather to seek solace and comfort must be respected, said Ibrar Sheikh.

### 2.1 Muslims and Jews in Aotearoa NZ

There has been more than 25 years of cooperation and coordination between FIANZ and Jewish organisations, including the NZ Jewish Council.

- We both share many common platforms, such as the Abrahamic Council, Interfaith and other.
- We also share common values with respect to working towards peace and social cohesion in Aotearoa.
- · Both have offered to help each other at times of adversity .

Throughout the previous 25 years, despite the many episodes of crisis in Israel and Palestine, we have maintained goodwill and understanding. Our communities suffer many common societal problems such as anti-Semitism and Islamophobia and we have worked together to address these.

After 15 March, the Jewish community, like all other communities extended their aroha. This has been cherished and has enriched our mutual respect and understanding. After 7th October, there have been several meetings, including under the auspices of the NZ Police, to ensure a peaceful pathway forward.

For FIANZ, we have unequivocally condemned all forms anti-Semitism and shall stridently advocate against any form of hate and discrimination in Aotearoa NZ. We have made several press statements and advisories in this respect.

For the record, FIANZ policy is firmly embedded in striving for social cohesion (see our national programme<sup>34</sup>). At times of extreme polarised views such as the current humanitarian crisis in Palestine, we prioritise peaceful debate on issues and lawful protest to raise awareness.

We also recognise that the social landscape (including social media) is such that there are vested individuals who will manipulate and connive to create divisions or provoke through hate speech for their own purpose.

To them we only have one response: "Asalaamu alaikum" (May be peace be with you).

# **3.00 CONFLATING ANTI-SEMITISM AND ANTI-ZIONISM**

There are some in New Zealand who conflate anti-Zionism with anti-semitism. This is even noted in a recent publication supported by the NZ Jewish Council which states, "... issues of antisemitism and anti-Zionism are often blurred and conflated..."<sup>35</sup>. They are two completely different concepts. One has a political baseline which the other is firmly based on faith-identity.

### 3.1 NZ Distinguished Academic and Expert

#### Q: Is anti-Zionism the same as anti Semitism?

**A:** No. One involves a Jewish homeland while the other is racism directed at all Jews, whatever their location. However, far right and antisemitic groups have sought to avoid being challenged or prosecuted by claiming they are anti-Zionist and therefore not covered by laws and policies which seek to address racism. We need to be clear of the distinction and the way in which it has been used to avoid being labelled antisemitic.<sup>36</sup>

**Distinguished Professor Paul Spoonley** was the Pro Vice-Chancellor of the College of Humanities and Social Sciences at Massey University. He was also a Principal Investigator on the MBIE-funded programme, Capturing the Diversity Dividend of Aotearoa New Zealand (2014-2020). He is a Fellow of the Royal Society of New Zealand and of the Auckland War Memorial Museum, and a Research Fellow of the Max Planck Institute for the Study of Religious and Ethnic Diversity. He was a Fulbright Senior Scholar at the University of California Berkeley. He was a Board member of the Foundation for Research, Science and Technology and is the current Chair of the TEC PBRF Panel for Social Sciences and Other Cultural/Social Studies.



# 4.00 THE NEED FOR THE FOURTH ESTATE TO PROVIDE BALANCED AND INFORMED PERSPECTIVES.

FIANZ is requesting the NZ media to be fair, balanced and objective when reporting on the current war in Gaza. The Fourth Estate has a tremendous responsibility, at this time of rampant social-media misinformation and disinformation, to provide news which is balanced from all perspectives. The NZ media is known to be professional and particularly careful in its reporting after March 15. Unfortunately, some of the standards have been unraveling since the start of the recent tragedy unfolding in Gaza.

Overseas editorial vested interests are creeping into the national media without their bias, accuracy or objectivity being challenged. The consequences are that at times there is just a one-side perspective.

FIANZ has undertaken a recent analysis of the NZ media with respect to the Gaza war and we have noted some issues.

We have intentionally not identified the specific NZ media for three reasons.

Firstly, our purpose is not to blame or criticise specific media, but to raise awareness of concerns. It hoped that such awareness shall lead to greater understanding of the responsibilities of the NZ media and confirm the high esteem in which we hold of journalistic standards in Aotearoa NZ.


Secondly, we do not believe that NZ media's editorial focus has any deliberate or premotivated bias towards either the Palestinian or Israeli perspective. Our view is that this may the result of individual journalists trying to do their best and not have sufficient time or resources to get information with different or alternative perspectives. It is hoped that the examples below will be lessons learned for the future.

Thirdly, many NZ journalists, copywriters, editors and producers of both print and audio-video media, may not be fully aware of the historical context of the current tragedy in Palestine and as such and in the rush to meet deadlines often rely on overseas 'legitimate media sources' without knowing that many of the foreign media have often vested interests and editorial directives. It is hoped that in future there will more scrutiny in this respect.

# 4.1 MYOPIA : A ONE-SIDED RELIANCE ON IDF (ISRAELI) SPOKESPERSONS

A balanced news of necessity, requires different perspectives. One NZ media has been glaringly remiss in this context. Within a defined time frame, this NZ media outlet gave the perspective of an IDF spokesperson 27 times, whilst the Palestinian spokesperson was only quoted 6 times, during the same period. A 400+% exposure on the IDF perspective, inevitably results in an one-sided pro-Israeli myopic viewpoint.

## 4.2 SANITISED NEWS : BODERING ON PROPAGANDA

It is well known in the propaganda paradigm that 'descriptors and imagery' are used to shape to a person's viewpoint and help reinforce a particular perspective.<sup>37</sup>

The following is one of 39 separate cases of what we have termed 'sanitising' the deadly use of force by the Israeli army in Gaza. This is a deficit approach to news. The NZ media needs to be more circumspect in simply copying news from overseas media with vested interests. They may be inadvertently become a propaganda medium.



# 4.3 CHRISTIAN CONTEXT MISSING: CRITICAL TO THE UNDERSTANDING OF CURRENT EVENTS

Most of the NZ media have highlighted the current genocide in Israel in Jewish versus Muslim terms. The Christian context is mostly missing .

We have found that very few NZ media use the perspectives of local Middle Eastern journalists to provide contextual and cultural balance. Almost all rely on the Western journalists to give their monoculture viewpoint on issues.

**Example 1:** The issue of local Christians in Jerusalem being the victims of hate by Israelis is almost a taboo topic in the NZ media. However, one major media outlet provided context and content to highlight this. It was by a local journalist who has a Israeli-Jewish mother and a Palestinian Christian father,

The article went on give context, by quoting local Palestinian Authority official," "The practice of spitting on non-Jews reflects the spread of extremism in Israeli society, especially among extremist settlers, and it is an expression of an attitude that begins with spitting and then turns into beating and killing," Such type of nuanced media provide meaningful understanding of the context of the current unfolding tragedy.

**Example 2:** On the day that two Christian women were killed by an Israeli sniper, the news was headlined worldwide, except in NZ. To our knowledge not one media outlet had this news of IDF snipers shooting an innocent Christian mother and daughter who were in a church compound. This highlights the tacit taboo on reporting Christian victims of the Israeli mass killing of Palestinians.



#### 4.4 NZ MEDIA WITHHOLDS CRITICAL INFORMATION FROM CIVIL SOCIETY AND POLICY MAKERS

It is not just a matter of bias and copying overseas news which plagues our NZ media, but there seems to be a complete absence of news analysis and critical (fact-checked) reporting which act as key information for foreign policy makers and civil society.

#### Example1 : Hostage Taking

Common Article 3 of the Geneva Conventions prohibits the taking of hostages. It is also prohibited by the Fourth Geneva Convention and is considered a grave breach thereof.<sup>38</sup> Whilst we have read, heard and seen much about the Hamas hostages, NZ media has been completely silent on Israeli-held hostages of Palestinians including Palestinian minors below age 16, held on what has been termed as 'security' grounds. This has been taking place for more than 20 years, without any access to courts or trials. They are, by every definition, hostages.

Putting aside the issue that Israeli authorities term them 'prisoners' rather than 'hostages' and the NZ media has blindly followed such blatant hypocritical labels. There was never any mention of "hostage exchange by both sides" in the media narrative<sup>40</sup>.

#### Example 2: One-Dimension

The UN Secretary- General's made a statement after October 7, 2023 that the "attacks by Hamas did not happen in a vacuum"<sup>41</sup>. The statement was later criticized by Israel and this was reported in NZ media.

Yet not one NZ media made any reference to the Palestinian President Mahmoud Abbas's statement a few days earlier at the UN , which provides the context .

....are struggling for freedom and independence, and to remind the Assembly of the tragedy caused by the Nakba 75 years ago, the effects of which continue to be exacerbated by the Israeli occupation of Palestinian territory.

The one-side information stream, inevitably provides a one-dimensional understanding of the current tragedy.

The NZ media has a responsibility to provide balanced information.
